CLEANING INSTRUCTIONS:
 Pretest each surface in an inconspicuous area to determine suitability. Mask off all surfaces which may come in contact with prespray, especially metal as it will readily etch the surface. Mix 1 to 1 with hot water. Prespray surface evenly with plastic sprayer. Agitate with a brush as needed. Brush agitation assists the cleaning process. Rinse thoroughly with SX-12 or Gekko. Neutralize with pre-spray of Viper Venom at 1 to 32 dilution with comparable dwell time, and rinse thoroughly. It is important to neutralize the residues of the acid from the grout to prevent gradual degradation of the grout cleaned. Viper Renew will readily damage marble, limestone, and other acid sensitive materials. Do not mix with other chemicals, and store only in closed original container.

REMOVING EFFLORESCENCE:
 Apply to small areas of grout and agitate with a brush. Limit dwell time by extracting immediately and completely with water. Dry quickly with air movers as excess moisture is the cause of efflorescence.

INSTRUCCIONES:
 Haga una prueba preliminar en una parte poco visible de cada superficie. Cubra todas las superficies que podrían entrar en contacto con el rociado preliminar, especialmente las metálicas. Mezcle el producto con agua caliente en una proporción de 1:1. Rocíe la superficie en forma pareja con el rociador de plástico. Cepille vigorosamente la superficie según sea necesario, ya que esto facilita el proceso de limpieza. Enjuague completamente con SX-12 o con la herramienta Gekko. Neutralice con un rociado preliminar de Viper Venom diluido en una proporción de 1:32, con tiempo de reposo comparable, luego enjuague completamente. Es importante neutralizar los residuos del ácido en la lechada para evitar la degradación gradual de ésta cuando se limpia.

ADVERTENCIA: Viper Renew daña rápidamente el mármol, la piedra caliza y otros materiales sensibles al ácido. No lo mezcle con otros productos químicos. Guárdelo únicamente en el recipiente original.

ELIMINACIÓN DE LA EFLORESCENCIA:
 Aplique Viper Renew a las áreas pequeñas de la lechada y cepille firmemente. Limite el tiempo de reposo extrayendo el producto con agua en forma inmediata y completa. Seque rápidamente con ventiladores, ya que el exceso de la humedad es lo que causa la eflorescencia.
