DIRECTIONS

Hydro Break is designed for use in the Hydro-Force injection sprayer and other types of pump or electric sprayers. Results are best when mixed with hot water.

For use with Hydro Force: Add Hydro Break directly to the 5 quart container. The proper dilution is automatically achieved when dilution rate is set at 1 to 8.

For Pump or Electric Sprayers: Dilute 1 part Hydro Break to 8 parts hot water (8 scoops to 1 gallon hot water).

Application: Spray on traffic areas until evenly damp. Allow to dwell for 5-15 minutes. Extract with normal cleaning process.
