### DIRECTIONS

For normal cleaning: Dilute 1 part Flex to 16 parts hot water (8 oz. Flex to 1 gallon hot water).

Hydro-Force Injection Sprayer - Dilute 1 part Flex with 1 part water in the Hydro-Force 5

quart container and use with 1 to 8 metering tip to achieve 1 to 16 dilution.

For special case, hard-to-remove or heavy soil, dilute 1 part Flex to 8 parts hot water (16 oz. Flex to 1 gallon hot water).

In Hydro-Force Injection Sprayer, add Flex directly to the Hydro-Force 5 quart container and use with 1 to 8 metering tip.
