



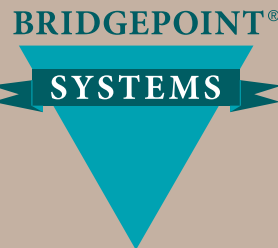

### INSTRUCCIONES:

Para equipos portátiles: Mezcle 2 onzas de POWER POINT con 5 galones de agua (un poco más de 3 ml por litro—1:320) para obtener una solución de limpieza lista para usarse.
