### DIRECTIONS

Carpet Directions: Mix 4 to 6 ounces of Fab-Set per gallon of water (1:32 to 1:21) and apply with a standard pump or power sprayer. Apply after cleaning.

Upholstery: Mix 4 to 6 ounces of Fab-Set per gallon of water (1:32 to 1:21). Fab-Set is excellent as a final rinse through extraction machines. It may be used as a final rinse through your machine or spray-misted on fabric after cleaning. (See the Bridgepoint Fabric Care Guide.)

Portable Extractor: Mix 2 ounces of solution to five gallons of water in extraction tank (1 to 320).

For Truck Mount Use: Mix 1 quart of Fab-Set per 5 gallons of water (1 to 20). Meter as needed.

### INSTRUCCIONES

Alfombras: Mezcle de 4 a 6 onzas de Fab-Set por galón de agua (aprox. de 32 a 48 ml por litro— 1:32 a 1:21) y luego rocíe con un rociador estándar de bomba o eléctrico. Aplíquelo después de la etapa de limpieza.

Tapicería: Mezcle de 4 a 6 onzas de Fab-Set por cada galón de agua (aprox. de 32 a 48 ml por litro— 1:32 a 1:21) y luego rocíelo, extráigalo o limpie la superficie con esponja después de limpiarla.

Extractor Portatol: Mezcle 2 onzas de solución a cinco galones de agua en un tanque de extracción (1:320).

Para uso de montaje en camión: mezcle 1 cuarto de galón de Fab-Set por cada 5 galones de agua (1:20). Medidor según sea necesario.
