

DIRECTIONS

Professional use only.

1. Test in an inconspicuous area for safe use on fiber or surface. Do not use on acetate as fabric will dissolve on contact.
2. Remove excess contaminant before applying All Solv Extreme™.
3. Start stain removal process with Avege Pro™ unless it is fingernail polish, paint or a resin type stain. Follow directions for use of Avege Pro™.
4. Apply All Solv Extreme™ to the stained area. Blot with a towel until majority of contaminant color is removed. Apply Avege Pro™, agitate and rinse. If fabric is not compatible with water, substitute Bridgepoint Solvent Clean for Avege Pro™. Repeat if necessary.

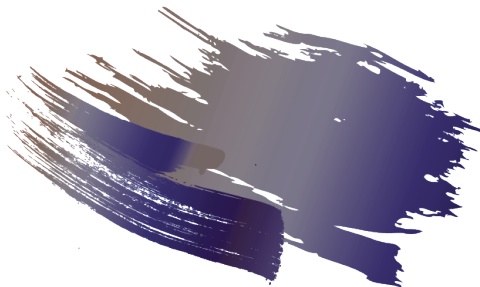
