#### DIRECTIONS

Pretest in inconspicuous area for dye and fabric stability. Medium to heavy soil: Dilute one part Avenge Fabric Prespray with one part hot water. Extra Heavy soil: Use as is. Do not dilute.

Application: Apply evenly to soiled areas. Agitate with a horsehair brush. Allow to dwell for 5 to 10 minutes but do not allow to dry before extraction. Extract using Avenge Clean Rinse or Bridgepoint Fab Set.

Aplicación: Aplique el producto parejamente a las áreas sucias. Agítelo con un cepillo de cerda de caballo. Deje reposar el producto por unos 5 ó 10 minutos, pero no deje que se seque antes de extraerlo. Extráigalo usando Avenge Clean rinse o Bridgepoint Fab Set.
