DIRECTIONS:

Grout and Tile Maintenance: Dilute 1 part Viper Venom II with 16 parts hot water.

Grout and Tile Restoration: For special case, hard-to-remove soils, dilute 1 part Viper Venom II with 4 parts hot water for extreme cleaning. Low pressure spray onto grout and tile and allow to dwell for 5 minutes, but do not allow to dry before cleaning/extracting. Add oxygen and/or citrus booster when necessary for grout whitening and enhanced degreasing.

For wood floors: Use Hydro-Force Wood Fresh hardwood cleaner.

For stone (marble, travertine, Saltillo): Use Viper Stone cleaner.

For vinyl (VCT, LVT, LVP): Use Viper 7 neutral cleaner.

For removing hard water (mineral) deposits from tile and grout: Use Viper Renew acid cleaner.
