### DIRECTIONS FOR CARPETS

Direct Spray: Dilute 2 to 8 ounces per gallon depending on severity of the odor. Spray evenly over affected areas.

Extraction Cleaning: Portable—Add ½ to 1 ounce per gallon of ready-to-use solution. Truckmount—Add 12 ounces to 5 gallon container of concentrated emulsifier.

Other Uses: Add directly into cleaning solutions as needed to control and eliminate odors. 1 to 3 ounces per gallon added to cleaning solutions, 2 to 8 ounces per gallon for direct spray.

Note: For heavy or severe odors, add Bio-Charge at 8 oz. per gallon of ready-to-use deodorizer.

### INSTRUCCIONES PARA LAS ALFOMBRAS

Rociado directo: Diluya de 2 a 8 onzas por galón (59 a 237 ml por 3.8 litros), dependiendo de la severidad del olor. Rocíelo directamente sobre las áreas afectadas.

Limpeza por extracción: Portátil—Agregue de ½ onza a 1 onza por galón de la solución RTU (15 a 30 ml por 3.8 litros). Montaje en camión— Agregue 12 onzas al recipiente de 5 galones de emulsionador concentrado (355 ml por 19 litros).

Otros Usos: Agregue el producto directamente a las soluciones de limpieza según sea necesario para controlar y eliminar los olores. Agregue de 1 a 3 onzas por galón a las soluciones de limpieza (30 a 89 ml por 3.8 litros), o de 2 a 8 onzas por galón para el rociado directo (59 a 237 ml por 3.8 litros).

Nota: Para los olores fuertes o severos, agregue Bio-Charge en una proporción de 8 onzas por galón de desodorizante listo para su uso (237 ml por 3.8 litros).
