Pro Strip

Product Description:

Pro-Strip is a heavy duty cleaner designed to remove soils and deposits from floors. It is especially good for cleaning grout lines on floors that have been collecting soils and deposits for long periods of time. Although cleaned regularly ordinary cleaners do not completely remove all of the soils from grout lines and it gradually builds up. Occasional cleaning with Pro-Strip will restore the floor to a new appearance. 1 Gallon of Pro-Strip will clean about 400 square feet of surface.

Pro-Strip is not to be used as a routine cleaner but for occasional use when necessary to restore floors to a new appearance.

Directions for use:

Pro-Strip is not diluted for use. Evenly apply to the floor at a rate of 1/2 gallon to 100 square feet of floor being cleaned. Thoroughly scrub the floor using a buffing machine equipped with a scrub brush. Vacuum floors dry. Rinse with clear water.

Note:

Pro-Strip contains free caustic and is extremely irritating to the eyes and skin. A face shield, rubber gloves and rubber safety shoes should be worn when handling and using Pro-Strip.

For eye contact thoroughly rinse eyes with cool running water for at least 15 minutes. Hold eyelids open to ensure rinsing the entire eyeball. Immediately seek medical attention.

For skin contact wash affected area with running water until the slippery feeling is gone. See a physician if irritation persists. Launder clothing before reuse. Discard contaminated shoes.

If swallowed do not cause vomiting. Dilute with

several glasses of water or milk. Immediately get medical attention. Do not give anything by mouth to an unconscious person.
